Ordinance No. 04-01

AN ORDINANCE OF PARK COUNTY, COLORADO AMENDING ORDINANCE NO. 96-02 BY ADOPTING BY REFERENCE THE 2003 EDITION OF THE 'MODEL TRAFFIC CODE FOR COLORADO;' REPEALING THOSE PORTIONS OF ORDINANCE NO. 96-02 WHICH CONFLICT WITH THIS ORDINANCE; AND AMENDING THE PENALTY PROVISIONS.

WHEREAS, the Park County Board of County Commissioners from time to time has previously passed ordinances adopting the current editions of the 'Model Traffic Code for Colorado;' and

WHEREAS, Ordinance No. 96-02 was the most recent such ordinance enacted by the Board of County Commissioners; and

WHEREAS, the Board of County Commissioners, upon the request of the Park County Sheriff, deems it appropriate to adopt by reference the 2003 edition of the 'Model Traffic Code for Colorado,' repeal portions of Ordinance 96-02 that conflict with this Ordinance, and amend the penalty provisions; and

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS FOR PARK COUNTY:

Section 1. There is hereby adopted by reference Articles I and II, inclusive, of the 2003 edition of the 'Model Traffic Code for Colorado.' Three (3) copies of the 2003 edition of the 'Model Traffic Code for Colorado' are now filed with the office of the Park County Clerk and may be inspected during regular business hours.

Section 2. The following section of Ordinance 96-02, under Section 4 entitled 'Penalties,' is hereby amended to read as follows:

(b) Every person who violates any provision stated or adopted in this ordinance shall be punished for each separate violation as provided in Section 42-4-1701 of the Colorado Revised Statutes, unless a fine is specified for an offense pursuant to the penalty assessment procedure described below.


Section 3. Any provisions of Ordinance 96-02, which conflict with this Ordinance 04-01, are hereby repealed. The remaining portions of Ordinance 96-02 shall remain in full force and effect.

Section 4. Pursuant to C.R.S. § 30-15-405, this ordinance shall be published in full following its initial introduction and reading, published by title only following final adoption by the Board of County Commissioners, and shall be effective thirty (30) days following such publication by title only.
